

Objectives of the Society

- > To actively work for creating a dowry free society.
- To create awareness and educate the society about ineffectiveness, inefficacy and unfairness of current dowry and harassment laws like 498a.
- To crate awareness about detrimental effects of current dowry laws (like 498a) on the foundation of institution of marriage in India.
- To crate awareness about the fact that current dowry laws are harmful not only to husband and his relatives but also to wife and her family.
- > To get the dowry laws amended/reformed so that they are effective and justified.
- To enable the females, who are real victims of dowry problem, in getting timely justice by reducing number of fake cases running in courts.
- To ensure speedy disposal of women harassment cases from the courts, which should be bases on truth, justice and not as an outcome of patience testing and frustration.
- To ensure speedy disposal of cases, especially where children are involved, not subjecting a child to choose between parents.
- To enable numerous innocent victims to gather on a common platform and represent their perspective in a clear and concise and effective manner.
- To mobilize the victims along with society, for retaliating against unjustified procedures and legal systems.
- To raise vigilance and resist injustice caused by false complaints failed under IPC 498A and Dowry Prohibition Act leading to wrongful imprisonment of innocent individuals.
- > To monitor and expedite Investigations by the police.
- > To discourage false and malafide FIR and malicious prosecutions.

- > Legal action against those who implicate innocents or catalyze this abuse.
- > To enable the innocents to get anticipatory bail, before being jailed in a blind manner.
- > To establish telephonic help-line.
- > To establish legal aid clinics to provide relief to such victims of misuse of law.
- > To provide counseling / emotional support to the victims.
- > To establish family counseling centers to facilitate reconciliation, wherever possible.
- To promote resolution of family disputes by reconciliation and understanding through counseling.
- To mobilize media for spreading the awareness about injustice exerted through false cases under sections 498a, 304B etc.
- To take up cases related International Human Rights violation and violation of fundamental Rights as per Indian constitution and raise these cases at appropriate platforms.
- To gather evidence and statistics for communication of our viewpoint to media, authorities, government and to the society.
- To analyze the strategy and implementation of the government and police, related to tackling dowry problems. To find out and communicate the shortcomings in these strategies.
- To monitor non-compliance of policy decisions, guidelines or instructions, relating to matrimonial harmony or women harassment cases by public authorities and take up the issue at appropriate front.
- To collaborate with different sections of society, government bodies and legal authorities for the betterment of civilized society.
- To perform all such acts as may be necessary for the achievements and accomplishment of the above mentioned aims and objectives.
